The ARSO/TC 05 on its national mirror technical committee, UNBS TC 204 on Fruits, vegetables, tubers and processed products has developed 10 Draft African Standards (DARS) in accordance with the procedures for development of African Standards. The Draft standards include:

- DARS 934:2024, Dasheen leaves — Specification
- DARS 926:2024, Fresh cauliflowers — Specification
- DARS 928:2024, Fresh lettuces and endives — Specification
- DARS 932:2024, Fresh romaine lettuce - Specification
- DARS 943:2024, Fresh collard greens or broccoli greens — Specification
- DARS 993:2024, Fresh dandelion greens — Specification
- DARS 925:2024, Fresh broccoli — Specification
- DARS 923:2024, Fresh Chinese cabbages — Specification
- DARS 924:2024, Fresh Brussels sprouts — Specification
