REQUEST FOR COMMENTS ON DRAFT EAST AFRICAN STANDARDS

The EASC/TC 009 on Food packaging and labelling and its national mirror technical committee, UNBS/TC 208 on Food labelling and hygiene has developed five Draft East African Standards (DEAS) as indicated below in accordance with the procedures for development of East African Standards:

- DEAS 38: 2024, Labelling of pre-packaged foods — General requirements
- DEAS 1244: 2024, General standard for the labelling of foods additives when sold as such
- DEAS 1245: 2024, Packaging and transport of fresh fruit and vegetable — Code of practice
- DEAS 1246: 2024, General standard for labelling non-retails container for foods
- DEAS 1247: 2024, Guidelines on Front of Pack Nutrition Labelling

The Draft East African standards are now being circulated to stakeholders and the public for comments on their suitability for implementation. Find the draft standard attached.
