## Request for comments on Draft Uganda Standards

The Uganda National Bureau of Standards through its technical committee, UNBS/TC108, Steel and Aluminium in liaison with UNBS/TC109, Pipes and Fittings has developed the following draft Uganda standard:

1. **DUS 2727:2024 Sponge iron/direct reduced iron (DRI) hot briquette iron (HBI) and cold briquette iron (CBI) for steelmaking — Specification**
2. **DUS 2724:2024 Carbon steel cast billet ingots, billets, blooms and slabs for re-rolling into steel for general structural purposes —Specification**
3. **DUS 2270: 2024, copper alloy fancy single taps, combination tap assembly and stop valves for water services - specification**
4. **DUS 2428: 2024, kitchen wares made of stainless steel – requirements.**
5. **DUS 2255: 2024, stainless steel seamless pipes and tubes for general services — specification**
